THERE WERE CALIFORNIA BILLS...

- To assign a social worker to every resident at birth?
- To ban pastors and counselors from using the Bible in counseling
- To allow children ages 13 and up to make their own medical decisions without parental knowledge or consent including vaccinations, rehabilitation drugs, and gender reassignment surgery?
- To ban homeschooling outright?
- To require bathroom inspections for homeschoolers?
- To add mandatory testing, teacher certification, curriculum standards, and health and safety standards to the requirements for homeschooling?



California introduces more than 3,000 legislative bills every year, with every one of those bills having multiple amendments and variations. We go through them, looking for anything that would impact the right of parents to direct the raising of their children.

Nathan Pierce has over 25 years of experience doing advocacy work in Sacramento. His current role of Executive Director includes screening the thousands of bills that pour into the California Legislature each year, closely watching for any that could harm our freedoms as parents, and alerting parents to contact their legislators.

What do we do?

Our mission is to protect the right of parents to train, educate, and care for their children privately without government interference. We work to detect, analyze, monitor and intervene in any legislation that would impact these freedoms in California. We believe that the Gospel and the Bible speak to every area of life and therefore we endeavor to evaluate all bills and proposals from a Biblical worldview.

Our primary focus is the protection of private homeschooling education, but we do monitor parental rights in all areas of life. When we find those bills, we take a variety of approaches to intervene and influence those bills, from personal phone calls and meetings, to supplying information, statistics, legislative research and analysis, and proposed amendment language.
