


The Rising Number of Homeschoolers



What is the Compulsory Attendance Age in California?

Helpful Article



- Compulsory Attendance Age in California is 6-18
- If your child will be 6-years-old on or before September 1st of this year, they need to be enrolled in a public school unless exempted
- Being enrolled in a private school exempts them from public school attendance
- If your child is 6 on on September 1st, they need to be enrolled in a school this fall

Withdrawing Your Child From School

Parents, whose children are currently enrolled in school, should follow steps in this article **before** taking any action to withdraw their children from their current school.

PROS AND CONS OF PRIVATE HOMESCHOOL OPTIONS IN CALIFORNIA

Private School Satellite Program (PSP)

ADVANTAGES

- Parent does not have to interact with the state, therefore neither the state nor local school district has information about the child's school or location where the education is taking place.
- Many PSP's offer help for parents educating their children beyond the private school affidavit.
- Diploma issued might have more credibility. • Might be able to participate in California CIF sports competition at the high school level.

Private School Satellite Program (PSP)

DISADVANTAGES

- Parents will generally have to pay for these services.
- Parents are under the authority of the PSP as it relates to their child's education.

Teaching Must Be In English?

REQUIREMENTS FOR NON-ENGLISH SPEAKING FAMILIES

- E.C. §30 provides an exception: “*...any private school may determine when and under what circumstances instruction may be given bilingually. It is the policy of the state to insure the mastery of English by all pupils in the schools; provided that bilingual instruction may be offered in those situations when such instruction is educationally advantageous to the pupils. Bilingual instruction is authorized to the extent that it does not interfere with the systematic, sequential, and regular instruction of all pupils in the English language.*”



In preparing a document that outlines your qualifications as a teacher, you should begin to think of yourself as an educator . The number one qualification is the fact that you are the parent . If you are a credentialed teacher, include that information, but do not be intimidated if you are not a state certified teacher .

Nearly all parents are capable to teach their own children . Be creative, but be honest . Put down any schooling, high school graduation and above . Include work experience, skills, hobbies, interests, and any personal information that adds to your qualifications to teach such as a love of traveling and adventure, an inquiring mind, or love of reading, etc . Other qualifications can be leader of youth organization, church school teacher, and attendance at educational conferences . CHEA of California holds such conferences twice a year . (Schools call this In-Service Training .)





 - Great sales on basic supplies at the beginning of the traditional school year
- Past Editions are often cheaper than the latest edition

- Make supplies like flash cards and timelines
- Choose curriculum that passes down well among siblings
- Choose publishers that allow copying within your family
